The Davis County Board of Supervisors met in regular session on Monday, June 26, 2023, with Chairman Ron Bride and Members Alan Yahnke and Dave Henderson present.

Dave Henderson made motion, seconded by Alan Yahnke and carried unanimously, to approve the agenda.

Alan Yahnke made motion, seconded by Dave Henderson and carried unanimously, to approve and sign the Minutes of Monday, June 19, 2023.

The Board met with custodian Randy Norman, who praised the Bloomfield Main Street organization for the clean-up that was done after the Hairy Nation Days celebration.

The Board met with Engineer Ryan Schock, who reported on the blading, mowing, hauling rock and ditching being done by the County crews. He discussed the U-barn road and the postponement from L.L. Pelling Company, who was hired to do seal coating on that road. They are delaying this until at least September. In the meantime, the road will be covered with limey chips and then calcium chloride, to provide dust control for traffic. The Engineer discussed some flood control and conservation projects with the Board and also noted that some Teasel areas were sprayed last week.

Dave Henderson made motion, seconded by Alan Yahnke and carried unanimously to approve a request from Ray Boas and Mark Wagner to use the courtyard to conduct a meeting to pray for rain.
