The Davis County Board of Supervisors met in regular session on Monday, July 31, 2023 with Chairman Ron Bride and Members Dave Henderson and Alan Yahnke present.

Dave Henderson made motion, seconded by Alan Yahnke and carried unanimously, to approve the agenda.

There were no comments offered by the public.

Alan Yahnke made motion, seconded by Dave Henderson and carried unanimously, to approve and sign the Minutes of Monday, July 24, 2023.

The Board met with custodian Randy Norman, who stated that he has begun additional watering for the flowerbeds and trees in the courtyard due to the severe drought conditions.

The Board met with Engineer Ryan Schock, who reported on the projects of the County crews. Besides the blading, mowing and hauling rock, they have been doing ditch work on Quail Ave. and will be moving to Umber Ave./310th St. The Engineer also stated that the \$33,000 donation provided by the Amish community for additional gravel was applied last week to Echo Ave. and Kiwi Blvd.

Ryan presented the Board with 2 projects to submit to Southern Iowa Conservation Development Authority, on Yak and Oak Avenues.

Alan Yahnke made motion, seconded by Dave Henderson and carried unanimously to approve the submission of these projects.

Dave Henderson made motion, seconded by Alan Yanke and carried unanimously to approve a utility permit to Rathbun Regional Water Association for a Mulberry Avenue location.

Bids were opened for the purchase and installation of a new HVAC system for the Davis County Welcome Center. Bids were from Charlie's Repair - \$7,747, Minck's Heating & Air Conditioning – \$9,172, Hawkeye (Weather King unit)- \$8,200, Hawkeye (Ruud unit) - \$10,100.

Dave Henderson made motion, seconded by Alan Yahnke and carried unanimously to approve the bid from Charlie's Repair.

Alan Yahnke made motion, seconded by Dave Henderson and carried unanimously, to approve funding of the HVAC system for the Davis County Welcome Center with part of the distribution received by the County, from the American Rescue Plan Act.

Dave Henderson made motion, seconded by Alan Yahnke and carried unanimously, to approve use of the Courthouse courtyard for the "Meet the Mustangs" event scheduled to be held on Wednesday, August 30, 2023.

All Board members reported on committee meetings attended.
