The Davis County Board of Supervisors met in regular session on Monday, September 11, 2023 with Chairman Ron Bride and Members Dave Henderson and Alan Yahnke present.

Dave Henderson made motion, seconded by Alan Yahnke and carried unanimously, to approve the agenda.

Alan Yahnke made motion, seconded by Dave Henderson and carried unanimously, to approve and sign the Minutes of Tuesday, September 5, 2023.

The meeting with custodian Randy Norman was cancelled.

The Board met with Engineer Ryan Schock, and discussed projects being completed by the County crews. He also noted that a portion of 240th Street (North and East of Pulaski) will be closed for several weeks to replace a bridge, Gee Asphalt will work on the road east of Drakesville soon, and Huggins Concrete has completed the placement of a few concrete patches at the intersection of 215th Street and Timber Ave.

Dave Henderson made motion, seconded by Alan Yahnke and carried unanimously, to approve a utility permit for Citizens' Mutual Telephone Company for access on 175th Street north of 180th Street.

Discussion was held concerning Davis County Jailer wages and the difficulty in finding employees to remain in those positions. The Board agreed that they would take the wages budgeted for one vacant jailer position and spread it among the remaining ones, in order to provide a more attractive salary for those positions.

Alan Yahnke made motion, seconded by Dave Henderson and carried unanimously to supersede the motion made on December 19, 2022, which allowed for a 5% increase of the previous years' wages for those positions, with a motion to increase the wages of the Jail Supervisor position from 24.98 to 26.98 per hour, and the other 3 Jailer position wages from 20.29 to 22.29 per hour, effective for the September 28, 2023 payroll date.

Kaitlin Sedore, Dispatch Supervisor was unable to meet with the Board as intended. However, Josh Sinnott brought the statistics needed for the review and discussion. It was determined the questions raised by these statistics would involve more than the just Board of Supervisors, and would require a meeting of the Bloomfield-Davis County Public Safety Commission meeting be scheduled for further discussion.
No action was taken.

All Board members reported on committee meetings attended.
