The Davis County Board of Supervisors met in regular session on Monday, September 18, 2023 with Chairman Ron Bride and Members Dave Henderson and Alan Yahnke present.

Alan Yahnke made motion, seconded by Dave Henderson and carried unanimously, to approve the agenda.

Dave Henderson made motion, seconded by Alan Yahnke and carried unanimously, to approve and sign the Minutes of Monday, September 11, 2023.

The Board met with custodian Randy Norman. He reported bids have been received for boiler repairs and for seeding of the courtyard lawn around the gazebo.

The Board met with County Road Maintenance Supervisor Kurt Bulechek, who discussed the blading, mowing, rock hauling, ditching activities of the County crews. He also reported piling has been driven on one side of Altheide Bridge and shoulder work on J40 and north/south of White's corner has begun.

Dave Henderson made motion, seconded by Alan Yahnke and carried unanimously, to approve the contract with Renodry USA at a cost of \$22,194.00 for a dehydration system which eliminates rising moisture and salts in the courthouse foundation.

Dave Henderson made motion, seconded by Alan Yahnke and carried unanimously to approve the application request for partial distribution of The American Rescue Plan Act funds for installation of the Renodry units to remediate courthouse foundation moisture.

Alan Yahnke made motion, seconded by Dave Henderson and carried unanimously to approve the tire disposal plan and provide funding.

A staff meeting was held to discuss potential changes to the job description of the Custodian/Maintenance position.

All Board members reported on committee meetings attended.
