Deadline is 5 p.m.</p> <p><b>School Election Final Withdrawal Deadline</b> Last day for candidates to withdrawal by filing a written request with the <b>School Secretary</b>. Deadline is 5 p.m.</p> <p><b>City Election Candidate Objection Deadline</b> Last day to file written objections to nomination papers of eligibility of a candidate with the <b>City Clerk</b>. Deadline is 5 p.m.</p> <p><b>School &amp; Community College Election Objection Deadline</b> Last day to file written objections to nomination papers or eligibility of a candidate with the <b>School Secretary</b> or Community College Board Secretary.</p> <p><b>Auditor's Office, City Clerk's Office and School Secretary's Office must be open until 5 p.m.</b></p>
<p><b>Mon, Oct 9, 2023</b></p>	<p><b>Satelite Voting Petition Deadline for Regular City/School Election</b></p>

<p><b>Mon, Oct 23, 2023</b></p>	<p><b>Voter Pre-Registration Deadline</b> The deadline to pre-register to vote for the City/School Election is 5 p.m. This applies to registration in person (including registration at driver's license stations or agencies) or by mail.</p> <p>After today, a person may register to vote at the Auditor's Office and vote an absentee ballot. The process is the same as for registering to vote on election day.</p> <p><b>Deadline to request an absentee ballot be mailed.</b></p> <p><b>Worry-Free Postmark Date</b> Mailed voter registration forms which are postmarked on or before today are considered on time to be pre-registered for the City/School Election even if they are received after the voter pre-registration deadline.</p> <p>Voters admitted to hospitals or nursing homes after 5 p.m. today may call to request delivery of an absentee ballot for the City/School Election. Deadline for a telephone request is 4 p.m. on election day.</p> <p><b>Auditor's Office must be open from 8 a.m. to 5 p.m.</b></p>
<p><b>Fri, Nov 3, 2023</b></p>	<p><b>Last day to submit written challenges to absentee voters</b> A person qualified to vote in the election may submit a written challenge to the qualifications of an absentee voter until 5 p.m. to the Auditor.</p> <p><b>Auditor's Office must be open until 5 p.m.</b></p>
<p><b>Mon, Nov 6, 2023</b></p>	<p><b>In-person absentee ballot deadline for City/School Election</b> Last day to vote an absentee ballot in person at the Auditor's Office.</p>
<p><b>Tues, Nov 7, 2023</b></p>	<p><b>City/School Election Day</b> Polls are open from 7 a.m. until 8 p.m.</p> <p>All absentee ballots (except UOCAVA and Safe at Home) must be received in the Auditor's Office by 8 p.m. to be considered on time to be counted.</p> <p><b>Last day for voters to fix incomplete Affidavits for the City/School Election.</b> Voters have until 8 p.m. to fix incomplete Affidavit envelopes at the Auditor's Office.</p>
<p><b>Mon, Nov 13, 2023</b></p>	<p><b>1st-Tier County Canvas of Votes for the City/School Election</b></p>
<p><b>Thurs, Nov 16, 2023</b></p>	<p><b>Recount Request Deadline for Regular City/School Election</b> Requests must be written and filed with the Auditor by 5 p.m. on the third day after the county canvass.</p> <p><b>Auditor's Office must be open until 5 p.m.</b></p>
<p><b>Fri, Nov 17, 2023</b></p>	<p><b>Election Contest Notice for City Election</b> Statement of intent to contest the election must be filed in the <b>City Clerk's</b> office no later than 10 days after the election.</p>
<p><b>Mon, Nov 20, 2023</b></p>	<p><b>2nd-Tier County Canvass for School Election</b></p>

<p><b>Mon, Nov 27, 2023</b></p>	<p><b>Write-In Winner Resignation Deadline for Cities</b> If a person is elected by write-in votes, they can submit their resignation in writing to the <b>City Clerk</b> by 5 p.m. by the tenth day after the canvass.</p> <p><b>City Clerk's Office must be open until 5 p.m. if necessary.</b></p>
<p><b>Mon, Dec 11, 2023</b></p>	<p><b>Election Contest Notice Deadline for School District Candidates</b> Statement of intent to contest election must be filed in the Auditor's Office within 20 days after the the the apparent winner was declared elected.</p>
