The Davis County Board of Supervisors met in regular session on Monday, November 13, 2023 with Chairman Ron Bride and Members Dave Henderson and Alan Yahnke present.

Dave Henderson made motion, seconded by Alan Yahnke and carried unanimously, to approve the agenda.

Dave Henderson made motion, seconded by Alan Yahnke and carried unanimously, to approve and sign the Minutes of Monday, November 6, 2023.

The Board met with County Engineer Ryan Schock, who reported on the blading, mowing, rock hauling and ditching activities of the County crews.

The Board met with County Assessor Lois Heckethorn regarding the Family Farm Credit applications. There were 50 applications, 42 cancellations and 1 denial. Alan Yahnke made motion, seconded by Dave Henderson and carried unanimously to approve/deny applications as presented.

Alan Yahnke made motion, seconded by Ron Bride, and carried unanimously, to re-adopt and approve Fair Housing Policy to change the contact from Area 15 to Davis County Board of Supervisors for participation in the CDBG Program.

The approved Fair Housing policy, summarized, states that Davis County advises the public that it will administer its assisted programs and activities relating to housing and community development in a manner to affirmatively further fair housing in the sale or rental of housing, the financing of housing and the provision of brokerage services.

Davis County shall assist individuals who believe they have been subject to discrimination in housing through the resources of the Iowa Civil Rights Commission or the U. S. Department of Housing and Urban Development.

Davis County has designated the following office as the contact to coordinate efforts to comply with this policy: Dave Henderson, Davis County Board of Supervisors, 100 Courthouse Square, Bloomfield IA 52537, phone number 641-664-2344, Monday – Friday from 8:00 AM. to 4:00 PM.

Dave Henderson made motion, seconded by Alan Yahnke, and carried unanimously, to approve the revision to Section Five of the Employee Handbook regarding Insurance Benefits. The County will pay a portion of the premium for both the single/family plans for health and dental coverage.

All Board members reported on committee meetings attended.

The Board reconvened at 3:00 PM for the canvass of votes from the November 7, 2023 City-School Election. Results were unchanged from the previously reported unofficial results.
