The Davis County Board of Supervisors met in regular session on Monday, November 20, 2023 with Chairman Ron Bride and Members Dave Henderson and Alan Yahnke present.

Dave Henderson made motion, seconded by Alan Yahnke and carried unanimously, to approve the agenda.

Dave Henderson made motion, seconded by Alan Yahnke and carried unanimously, to approve and sign the Minutes of Monday, November 13, 2023.

The Board met with County Engineer Ryan Schock, who reported on the blading, mowing, rock hauling and ditching activities of the County crews.

Dave Henderson made motion, seconded by Alan Yahnke and carried unanimously, to approve a utility permit for Farmers Mutual Telephone Company on Apple Avenue.

A discussion was held with employees from Davis Center/Optimae LifeServices, Dawn McCarty and Harry Williams, regarding elevator maintenance and updates needed for the heating system. County funding of these needs were considered and will be approved at a later meeting.

The Board held discussion with Assistant County Attorney Ashley Walkup, and determined an amount of increase to present to Optimae LifeServices for negotiations of the current lease agreement, pending contract renewal.

The Board discussed the matter of insurance for the First Responders group, and after discussion, it was decided that a group meeting with the Davis County Hospital, the Davis County Board of Supervisors and the First Responders group all together would be appropriate and more productive. No immediate action was taken, but hopes are to schedule that meeting.

All Board members reported on committee meetings attended.
