The Davis County Board of Supervisors met in regular session on Monday, October 30, 2023 with Chairman Ron Bride and Members Dave Henderson and Alan Yahnke present.

Dave Henderson made motion, seconded by Alan Yahnke and carried unanimously, to approve the agenda.

Alan Yahnke made motion, seconded by Dave Henderson and carried unanimously, to approve and sign the Minutes of Monday, October 23, 2023.

The Board met with County Engineer Ryan Schock, who discussed the mowing, blading, rock hauling and ditching activities of the County crews.

Dave Henderson made motion, seconded by Alan Yahnke and carried unanimously, to approve a County line maintenance 28E agreement with Van Buren County. The agreement defines the duties and responsibilities of adjoining Counties with regard to construction and maintenance of County line roads between their respective jurisdictions, and roads under each COUNTY'S jurisdiction which are wholly within one COUNTY, but provide access to the adjoining County, due to discontinuation or legally placed restrictions.

Alan Yahnke made motion, seconded by Dave Henderson and carried unanimously, to approve the Weed Commissioner's annual report.

Dave Henderson made motion, seconded by Alan Yahnke and carried unanimously, to approve a revision to the Employee Handbook regarding the effective start date for new employee's insurance coverage. The revision will change the beginning date of insurance coverage for a new enrollee from the first day of employment to the first day of the month following their hire date.

Alan Yahnke made motion, seconded by Dave Henderson and carried unanimously, to approve the Iowa Dept of Health and Human Services Cost Allocation Plan completed by Cost Advisory Services of Johnston, IA.
