January 8, 2024 Bloomfield, Iowa Boardroom-Courthouse 8:30 A.M.

The Davis County Board of Supervisors met in regular session on Monday, January 8, 2024 with Chairman David Henderson and Members Alan Yahnke and Ron Bride present.

Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve the agenda.

Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to approve and sign the Minutes of Tuesday, January 2, 2024.

The Board met with Engineer Ryan Schock, who reported on the rock hauling, brush cutting, and blading being done by the County crews.

Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve an easement to Southern Iowa Electric Cooperative for an electric line right-of-way.

The Board met with County Attorney Rick Lynch, who requested that his associate, Kelly Lynch, be designated as an assistant county attorney, at no financial cost to the County, for the purpose of assisting his office with court proceedings in the Davis County Courthouse.

Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve the title of Assistant County Attorney be given to Kelly Lynch.

Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to approve an amendment to the County Holiday Calendar. The regular "Fair Day" holiday was revised to a "floating" holiday.

Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to authorize the Davis County Auditor to pay, without prior approval, any freight, postage, water, lights, telephone, and contractual services; salaries and payrolls previously fixed by the Board.

Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to not pay expenses for national meetings without prior approval from this day forward.

Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to set the credit card limit amount for purchases without prior authorization, at \$3,000.00.

Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to approve the quarterly cash reports as presented from the Auditor, Recorder and Sheriff.

After much discussion regarding any potential salary increases for County employees, the Board decided to wait until after their next item on the agenda to make a decision.

The Board then met with Steven Preader, from Sagacity Benefits Insurance, regarding the County Employee Health Plan. Since his organization became the Third-Party Administrator for

the County health plan on July 1, 2023, the Board was interested to see the details of that activity, which he provided. The Board agreed that the reports were very positive and seemed to be going in the right direction for the future.

After the insurance presentation, the Board continued discussion regarding salary increases. Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to decrease the recommendations of the Compensation Board for each elected official named, by an amount of 62.5%. This would reduce the recommended amount of a 16% increase for the Sheriff, to a 6% increase, reduce the recommended amount of a 10% increase for the County Attorney, to a 3.75% increase, and the recommended amount of an 8% increase for the County Auditor, Recorder and Treasurer to an increase of 3%. The Supervisors approved lowering their recommended salary increase by an additional amount to result in a 2% increase.

Dave Henderson made motion, seconded by Ron Bride and carried unanimously, to approve an increase of 3% be given to all other full-time employees, not otherwise covered by a bargaining agreement.

All Board members reported on committee meetings attended.

Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve the following claims to be paid:
