The Davis County Board of Supervisors met in regular session on Monday, February 12, 2024 with Chairman David Henderson and Member Ron Bride present and member Alan Yahnke absent.

Ron Bride made motion, seconded by Dave Henderson and carried unanimously, to approve the agenda.

The Board met with Engineer Ryan Schock, who reported on the blading, rock hauling, and brush cutting activities of the County crews.

The Board signed contracts for two SIDCA (Southern Iowa Development Conservation Authority) projects, one for the 250<sup>th</sup> St. bridge project, and one for the Vetch Ave. bridge project, both to the lowest bidder being Davis County Excavation for the amounts of \$54,822.90 and \$49,900.50, respectively.
