The Davis County Board of Supervisors met in regular session on Monday, March 4, 2024 with Chairman David Henderson and Members Alan Yahnke and Ron Bride present.

Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve the agenda.

Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to approve and sign the Minutes of Monday, February 26, 2024.

The Board met with Don Walton and Carolyn Scott, from Master Gardeners Association, regarding the courtyard flower beds. They requested funding assistance to make improvements to the flower beds, but would design a specific plan later in the spring. No action was taken.

The Board met with Engineer Ryan Schock, who reported on the blading, rock hauling, and brush cutting activities of the County crews.

Chairman Dave Henderson opened the public hearing for road vacation for a portion of Yoke Blvd. One property owner joined via telephone. After discussion, Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to close the hearing.

Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to table all action on vacation of portion of Yoke Blvd., until more research can be done.

Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to sign the utility permit for Citizens Mutual Telephone Company for fiber optic installation on Yam, Venus, Wind, Wheat, 127<sup>th</sup>, 165<sup>th</sup> & 150<sup>th</sup> Streets.

Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve publication of the Fiscal Year 2025 Budget "Proposed Property Tax Levy Notice" and to set a public hearing for Monday, March 25, 2024 at 8:15 A.M., in the Board of Supervisors Office at the Davis County Courthouse.

Board Chairman Dave Henderson directed Auditor Linda Humphrey to publish the Fiscal Year 2025 Budget "Proposed Property Tax Levy Notice".

Dave Henderson made motion, seconded by Alan Yahnke and carried unanimously, to re-appoint Jeff Leyda to a 6-year term on the Civil Service Commission (to 2-16-2030).

The Board reviewed the County Home/Optimae Lease Agreement. Assistant County Attorney Ashley Walkup will send it to Optimae for their review. No action was taken.

All Board members reported on committee meetings attended.
