The Davis County Board of Supervisors met in regular session on Monday, March 25, 2024 with Chairman David Henderson and Members Alan Yahnke and Ron Bride present.

Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to approve the agenda.

Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to approve and sign the Minutes of Monday, March 18, 2024.

The Board met with Engineer Ryan Schock, who reported on the blading, rock hauling, and brush cutting activities of the County crews.

Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve the resolution to close and vacate a portion of Yoke Blvd.

Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to approve the bill of sale for the bridge on Yoke Blvd., for \$1.00 to its adjacent land owners, Fred Zeitler and Troy Lake, LLC.

Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to approve the resolution to close and vacate a portion of Umber Ave., (Dave Yahnke dead end).

Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to approve the utility permits for SIEC (Southern Iowa Electric Cooperative) for the following: Lilac Ave. (North of Bloomfield), Flax, Fir, 123rd St., Drakesville substation to Bloomfield, Mink Blvd., Lilac Ave. to Savannah, 280th St., J40 and Nuthatch Ave., but excluding one presented, from Mark Substation to Fairgrounds Road.

County Assessor Lois Heckethorn presented applications for approval/denial regarding the following: Impoundment Structure Exemption, Forest Reserve Exemption, Native Prairie and Wetlands, Industrial Property Tax Exemption.
