The Davis County Board of Supervisors met in regular session on Monday, May 20, 2024 with Chairman David Henderson and Member Ron Bride present. Member Alan Yahnke was absent.

Dave Henderson made motion, seconded by Ron Bride and carried unanimously, to approve the agenda.

Dave Henderson made motion, seconded by Ron Bride and carried unanimously, to approve and sign the Minutes of Monday, May 13, 2024.

During the time for public comments, Ashley Utt from Pathfinders Resource Conservation & Development, Inc. presented the Board with updates on various topics of tourism & economic development projects.

The Board met with Engineer Ryan Schock, who reported on the blading, rock hauling, and ditching activities of the County crews.

Dave Henderson made motion, seconded by Ron Bride and carried unanimously, to approve a utility permit for Southern Iowa Electric Cooperative, for a line running from Mark to the City of Bloomfield.

The Board discussed possible changes to the Mutchler Community Center 28E Agreement. The City is proposing changes to increase the Board Membership number from 3 to 5, simplifying the current 28E Agreement and making term limit revisions, etc.

Ron Bride made motion, seconded by Dave Henderson and carried unanimously, to approve the \$10,375.00 proposal for the exterior door repair at 203 S. Madison Street location. This cost includes the total replacement of the framework, a new door, windows and mail slots.

All Board members reported on committee meetings attended.
