The Davis County Board of Supervisors met in regular session on Monday, April 28, 2025 with Chairman Alan Yahnke and Members Ron Bride and David Henderson present.

David Henderson made motion, seconded by Ron Bride and carried unanimously, to approve the agenda.

Ron Bride made motion, seconded by David Henderson and carried unanimously, to approve and sign the Minutes of Monday, April 21, 2025.

The Board met with Engineer Ryan Schock, who reported on the current projects of the County crews, including blading, starting to narrow up roads, rock hauling and ditching. The Board signed contracts with Douds Stone and Cantera Aggregates for the 2025 Rock Program in accord with their April 21st action to approve twelve projects, awarding seven to Douds Stone and five to Cantera Aggregates.

The Board then discussed the continuation of repair and cleanup work because of water damage that occurred when a frozen water line broke. No action was taken.
