Ron Bride made motion, seconded by David Henderson and carried unanimously, to approve the agenda.

David Henderson made motion, seconded by Ron Bride and carried unanimously, to approve and sign the Minutes of Monday, June 2, 2025.

Per a request from representatives, Randy and Jeri Housholder to sell ice cream in the courtyard during the Fourth of July parade as a fundraiser for “Look to the Stars Cancer Foundation”, David Henderson made motion, seconded by Ron Bride and carried unanimously, to grant permission for said request.

The Board met with Engineer Ryan Schock, who reported on the blading, rock hauling and ditching work being completed by the County crews.

David Henderson made motion, seconded by Ron Bride and carried unanimously to approve and sign the utility permit for Rathbun Regional Water Association, Inc. on Quince Boulevard for Martin Gilbert.
