| Mon, Oct 20, 2025 | <p>Voter Pre-Registration Deadline The deadline to pre-register to vote for the City/School Election is 5 p.m. This applies to registration in person (including registration at driver's license stations or agencies) or by mail.</p> <p>After today, a person may register to vote at the Auditor's Office and vote an absentee ballot. The process is the same as for registering to vote on election day.</p> <p>Deadline to request an absentee ballot be mailed.</p> <p>Worry-Free Postmark Date Mailed voter registration forms which are postmarked on or before today are considered on time to be pre-registered for the City/School Election even if they are received after the voter pre-registration deadline.</p> <p>Voters admitted to hospitals or nursing homes after 5 p.m. today may call to request delivery of an absentee ballot for the City/School Election. Deadline for a telephone request is 4 p.m. on election day.</p> <p>Auditor's Office must be open from 8 a.m. to 5 p.m.</p> |
| Fri, Oct 31, 2025 | <p>Last day to submit written challenges to absentee voters A person qualified to vote in the election may submit a written challenge to the qualifications of an absentee voter until 5 p.m. to the Auditor.</p> <p>Auditor's Office must be open until 5 p.m.</p> |
| Mon, Nov 3, 2025 | <p>In-person absentee ballot deadline for City/School Election Last day to vote an absentee ballot in person at the Auditor's Office.</p> |
| Tues, Nov 4, 2025 | <p>City/School Election Day Polls are open from 7 a.m. until 8 p.m.</p> <p>All absentee ballots (except UOCAVA and Safe at Home) must be received in the Auditor's Office by 8 p.m. to be considered on time to be counted.</p> <p>Last day for voters to fix incomplete Affidavits for the City/School Election. Voters have until 8 p.m. to fix incomplete Affidavit envelopes at the Auditor's Office.</p> |
| Mon, Nov 10, 2025 | <p>1st-Tier County Canvas of Votes for the City/School Election</p> |
| Friday, Nov 14, 2025 | <p>Recount Request Deadline for Regular City/School Election Requests must be written and filed with the Auditor by 5 p.m. on the third day after the county canvass.</p> <p>Auditor's Office must be open until 5 p.m.</p> |
| Friday, Nov 14, 2025 | <p>Election Contest Notice for City Election Statement of intent to contest the election must be filed in the City Clerk's office no later than 10 days after the election.</p> |

| Mon, Dec 8, 2025 | Election Contest Notice Deadline for School District Candidates with 2nd Tier Statement of intent to contest election must be filed in the Auditor's Office within 20 days after the the the apparent winner was declared elected. |
