The Davis County Board of Supervisors met in regular session on Monday, July 14, 2025, with Chairman Alan Yahnke and Members Ron Bride and David Henderson present.

Ron Bride made motion, seconded by David Henderson and carried unanimously, to approve the agenda.

David Henderson made motion, seconded by Ron Bride and carried unanimously, to approve and sign the Minutes of Monday, July 7, 2025.

The Board met with County Assessor Jason Wagler, who presented the 2025 Homestead Credit and Exemption applications, the Disabled Veteran Homestead Credit applications and the Military Credit applications.

Dave Henderson made motion, seconded by Ron Bride and carried unanimously, to approve Homestead Credit and Exemption applications, Disabled Veteran Homestead applications and Military Credit applications per the recommendation of County Assessor, Jason Wagler.

The Board met with Engineer Ryan Schock, who reported on the blading, mowing, rock hauling and ditching work being completed by the County crews. He further reported that a total of 25.75 miles of Davis County roads have been regraded and narrowed.

David Henderson made motion, seconded by Ron Bride, and carried unanimously, to approve a utility permit for Citizens' Mutual Telephone Company on Owl Avenue.

Ron Bride made motion, seconded by David Henderson and carried unanimously, to approve and sign the ICAP (Iowa Communities Assurance Pool) annual renewal for County property and vehicle liability insurance coverage.

David Henderson made motion, seconded by Ron Bride and carried unanimously, to approve the annual GASB (Governmental Accounting Standards Board) 75 Actuarial Valuation for fiscal year 2025, as prepared by the Nyhart Company, Inc.
