The Davis County Board of Supervisors met in regular session on Monday, August 25, 2025 with Chairman Alan Yahnke and Members Ron Bride and David Henderson present.

David Henderson made motion, seconded by Ron Bride and carried unanimously, to approve the agenda.

David Henderson made motion, seconded by Ron Bride and carried unanimously, to approve and sign the Minutes of Monday, August 18, 2025.

The Board met with Engineer Ryan Schock, who reported on the blading, mowing, rock hauling, and ditching activities of the County crews. He further reported that all hard-surfaced roads, except the Floris Highway, will have been Crack-sealed, seal coated or slurry leveled in either 2024 or 2025.

After discussion with Engineer Schock, David Henderson made motion, seconded by Ron Bride and carried unanimously, to approve the Department of Transportation Funding Agreement for the “Richard Harris bridge” replacement project. As part of the funding agreement, the County agrees to pay \$254.00 to Leon Troyer for a permanent 0.3-acre easement and at Mr. Troyer’s request, give him the old bridge material instead of paying him for fence damage.
