The Davis County Board of Supervisors met in regular session on Monday, September 15, 2025, with Chairman Alan Yahnke and Members Ron Bride and David Henderson present.

Ron Bride made motion, seconded by David Henderson and carried unanimously, to approve the agenda.

David Henderson made motion, seconded by Ron Bride and carried unanimously, to approve and sign the Minutes of Monday, September 8, 2025.

The Board met with Engineer Ryan Schock, who reported on the blading, mowing, rock hauling, cross-road pipe installations and ditching work being completed by the County crews. Engineer Schock further reported a request from City of Drakesville Mayor, Bob Sampson, to place a concrete barricade at the northeast corner of the Quik Time lot at the intersection of Main and Washington Streets in Drakesville. After a brief discussion, the group concluded the Board has no authority over property in the City of Drakesville, but will not approve placement of a concrete barricade in the County right-of-way. Engineer Schock further reported his department would be advertising for a Track Hoe position in the next couple of weeks.
