The Davis County Board of Supervisors met in regular session on Monday, September 22, 2025 with Chairman Alan Yahnke and Members Ron Bride and David Henderson present.

David Henderson made motion, seconded by Ron Bride and carried unanimously, to approve the agenda.

Ron Bride made motion, seconded by David Henderson and carried unanimously, to approve and sign the Minutes of Monday, September 15, 2025.

The Board met with Engineer Ryan Schock, who reported on the blading, mowing, dozer work, rock hauling and ditching work being done by the County crews. Engineer Schock further reported the bridge replacement on 185th Street is now complete and work to replace the “Birdwatchers Bridge” will begin the first of November. He also reported that the deadline to apply for the backhoe operator position open in his department is Friday and five have applied so far.

The Board then met with Assistant County Attorney, Ashley Leyda-Walkup, who reported that the surveying companies she has been in touch with are working on bids but need more time given the complex, two-phase scope of work required to complete a new Jenny Carter Hill Subdivision survey. No action was taken.

After discussion regarding the City’s square paving project, David Henderson made motion, seconded by Ron Bride, and carried unanimously to approve the project to resurface the County’s five-and-a-half-foot portion at an estimated cost of \$17,864 for the overlay and \$3,810 to repaint the parking spaces.

After discussion and review of a letter from Iowa Communities Assurance Pool (ICAP), the County’s liability insurance company, regarding a claim made for water damage resulting from a broken water line in February, David Henderson made motion, seconded by Ron Bride and carried unanimously to approve the Chairman to sign and return ICAP’s Statement of Loss which states, in part, that after the County’s \$5,000.00 deductible and depreciation are applied, ICAP will issue a check for said claim for damages in the amount of \$16,198.24.

All Board members reported on committee meetings attended.

David Henderson made motion, seconded by Ron Bride and carried unanimously, to approve the following claims to be paid:
