September 29, 2025 Bloomfield, Iowa Courthouse Boardroom 8:30 A.M.

The Davis County Board of Supervisors met in regular session on Monday, September 29, 2025, with Chairman Alan Yahnke and Members Ron Bride and David Henderson present.

Ron Bride made motion, seconded by David Henderson and carried unanimously, to approve the agenda, with the exception to strike the review and approval of a Class C Retail Alcohol License for R & R's the Spot item.

David Henderson made motion, seconded by Ron Bride and carried unanimously, to approve and sign the Minutes of Monday, September 22, 2025.

The Board met with Steve Olinger, who expressed concerns that his driveway was adversely affected by a disc when the shoulder for the Floris Highway is being maintained by County crews. Mr. Olinger further inquired if the County would require him to obtain a permit to install a concrete driveway.

The Board met with Engineer Ryan Schock, who reported on the blading, mowing, rock hauling and ditching activities of the County Crews. He further reported having received 11 applicants for the track hoe position open in his department and will proceed with the next step of the hiring process which will be contacting some of the applicants and setting up interviews, hoping to have a successful candidate in place to begin employment mid-October. Engineer Schock and the Board then discussed concerns expressed by Steve Olinger and that no permit would be needed to install a concrete driveway other than a discussion between the citizen and the Engineer's office regarding the width and length measurement specifics to avoid the County's maintenance and snow removal equipment or the concrete driveway being damaged.

The Board then met with Davis County Development Executive Director, John Schroeder concerning an invoice from Iowa Department of Transportation for Home Base Iowa signage. After discussion, David Henderson made motion, seconded by Ron Bride and carried unanimously, for the County to pay the \$531.65 invoice to the Iowa Department of Transportation for the Home Base Iowa signs to be erected in Davis County.

The discussion regarding survey bids for the Jenny Carter Hills Subdivision was tabled until next week's meeting.

Auditor Kristi Goodson then informed the Board of current Human Resources Representative, Renee Von Bokern's retirement effective January 1, 2026. The group will look into hiring a new Human Resources consulting firm after they have received recommendations from Ms. Von Bokern and possibility other counties.

During Committee and Department Reports, Sheriff Zach Dunlavy reported there are currently 16 inmates housed at the jail. Currently, inmates receive three hot meals per day and he is looking into potentially saving approximately \$15,000 per year by eliminating one hot meal per day for breakfast and serving cereal instead. Sheriff Dunlavy further reported that prisoners who express interest have the opportunity to have a virtual Bible study with representatives from the Gideon Group International.
