The Davis County Board of Supervisors met in regular session on Monday, December 15, 2025, with Chairman Alan Yahnke and Members Ron Bride and David Henderson present.

David Henderson made motion, seconded by Ron Bride and carried unanimously, to approve the agenda.

Ron Bride made motion, seconded by David Henderson and carried unanimously, to approve and sign the Minutes of Monday, December 8, 2025.

The Board met with Engineer Ryan Schock who reported on the snow/road blading, and rock hauling activities of the County crews. He further reported that the card reader on the fuel system at the County Shed is still out of order and that Central Petroleum is coming today to see if they can fix the issue.

The Board then discussed a possible five percent increase in the County's health and dental premiums. No action was taken.

The Board discussed that some terms on the Board of Supervisor-appointed boards and committees will end December 31, 2025 and the need to contact some of these individuals to see if they are interested in serving additional terms. No further action was taken.

All Board members reported on committee meetings attended.

During the Committee and Department Reports section of the meeting, Sheriff Zach Dunlavy reported that serving jail inmates cereal instead of a hot meal for breakfast has resulted in a \$1,700.00 savings for the first partial month of its implementation. He further reported that training for tasers purchased three years ago is scheduled to happen this week.
