The Davis County Board of Supervisors met in regular session on Monday, January 19, 2026, with Chairman Ron Bride and Members David Henderson and Alan Yahnke present.

During the “public comments” section of the meeting, a resident voiced complaints concerning alleged damages he sustained from someone trespassing and dumping burn debris onto his property. He requested the Board to check into the status of his complaints.

David Henderson made motion, seconded by Alan Yahnke and carried unanimously, to approve the agenda.

Alan Yahnke made motion, seconded by David Henderson and carried unanimously, to approve and sign the Minutes of Monday, January 12, 2026.

The Board met with Engineer Ryan Schock, who reported on the blading, rock hauling, and brush cutting activities of the County crews. He further reported that work on the “Richard Harris Bridge” started today and that 202<sup>nd</sup> Street will be closed for the duration of the repair work.

Alan Yahnke made motion, seconded by David Henderson and carried unanimously, to approve signing a Resolution correcting Resolution #11325 recorded December 23, 2025, Instrument number 2025-1909, for the purpose of closing and vacating a portion of Franklin Avenue (Crimson Avenue) and Mill Street (186<sup>th</sup> Street).

Alan Yahnke made motion, seconded by David Henderson and carried unanimously to approve the Treasurer’s Semi-Annual Report.

Alan Yahnke made motion, seconded by David Henderson and carried unanimously, to approve the request by Nick Morton, Reed-Whisler Post #78 of the American Legion, to lower flags to half staff upon local veterans’ death during business hours on the day of their internment.

David Henderson made motion, seconded by Alan Yahnke and carried unanimously to approve re-appointing Ashley Utt as the County’s representative to the Mutchler Community Center Commission for a 3-year term, retroactively beginning on January 1, 2026 and ending December 31, 2028.

Chairman Ron Bride then addressed the results of an air quality test completed on the Courthouse by Alliance Environmental Services December 29, 2025. Present to represent the Eighth Judicial District were Chief Justice Shawn Showers, State Court Administrator, Bob Gast, and Eighth Judicial Court Administrator, Heidi Baker, who voiced questions and concerns regarding said test results. After several minutes of discussion, it was decided that since no one in the group is qualified as an expert to interpret said results, it would be best to get additional guidance from Alliance Environmental Services, who is scheduled on the Board’s agenda by telephone conference on Monday, January 26, 2026 at 9:30 a.m.

All Board members reported on committee meetings attended.

The Board reviewed proposed office budgets with Auditor Kristi Goodson.

David Henderson made motion, seconded by Alan Yahnke and carried unanimously, to approve the following claims to be paid:
