The Davis County Board of Supervisors met in regular session on Monday, January 5, 2026, with Chairman Ron Bride and Members David Henderson and Alan Yahnke present.

David Henderson made motion, seconded by Alan Yahnke and carried unanimously, to approve the agenda.

Alan Yahnke made motion, seconded by David Henderson and carried unanimously, to approve and sign the Minutes of Monday, January 2, 2026.

The Board then discussed a request by the Bloomfield Public Library to use the Courtyard on July 11, 2026 for a Renaissance Fair. David Henderson made motion, seconded by Alan Yahnke and carried unanimously, to table this matter until the January 12, 2026 regular meeting to allow time to obtain further details regarding a start time for said Renaissance Fair.

The Board then discussed the County's need to recruit a local optometrist. Alan Yahnke made motion, seconded by David Henderson and carried unanimously, to approve signing the Optometrist Recruitment Letter for Davis County.

At 10:00 a.m., Chairman Ron Bride called to open a public hearing for the FY2025-26 Budget Amendment. There being no written or oral comments given, Alan Yahnke made motion, seconded by David Henderson and carried unanimously to close the hearing.
