The Davis County Board of Supervisors met in regular session on Monday, April 24, 2023, with Chairman Ron Bride and Members Alan Yahnke and Dave Henderson present.

Dave Henderson made motion, seconded by Alan Yahnke and carried unanimously, to approve the agenda.

There were no comments offered by the public.

Dave Henderson made motion, seconded by Alan Yahnke and carried unanimously, to approve and sign the Minutes of Monday, April 17, 2023.

The Board met with custodian Randy Norman, who reported a purchase of 11 new fire extinguishers, to replace ones that have reached the end of their serviceable life.

The Board met with Engineer Ryan Schock, who confirmed that the paving project south of Pulaski has been completed, except for painting the lines. He added that 12 road employees would be attending a 2-day maintainer operator training this week, and that Binns & Stevens would be applying dust control beginning on May 15, 2023.

The Board met with Ryan White, from Acumen Advisors, to discuss the Davis County employee Health Plan renewal for Fiscal Year 2023-2024. Ryan presented statistics covering usage from the last year of the County's health claims. No action was taken.

All Board members reported on committee meetings attended.
