The Davis County Board of Supervisors met in regular session on Monday, April 8, 2024 with Chairman David Henderson and Members Alan Yahnke and Ron Bride present.

Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve the agenda.

Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to approve and sign the Minutes of Monday, April 1, 2024.

The Board met with Engineer Ryan Schock, who reported on the blading, rock hauling, and brush cutting activities of the County crews.

Bids were opened for the 2024 Rock program. There were 13 different roads identified in the project, and 2 different bidders, Douds Stone and Cantera Aggregates.

Alan Yahnke made motion, seconded by Ron Bride and carried unanimously to approve the 13 projects, awarding 11 to Douds Stone and 2 to Cantera Aggregates.

Alan Yahnke made motion, seconded by Ron Bride and carried unanimously, to approve utility permits for Citizens Mutual Telephone Company for Ebony Ave. and Quinine Ave., south to the State line.

Ron Bride made motion, seconded by Alan Yahnke and carried unanimously to approve the revision to the Davis County Courthouse Security Plan, changing the location of evacuation from its previous location to the County owned building at 102 S. Madison Street.

Alan Yahnke made motion, seconded by Ron Bride and carried unanimously to approve the Quarterly Cash Reports for the Auditor, Recorder and Sheriff.

All Board members reported on committee meetings attended.
