The Davis County Board of Supervisors met in regular session on Monday, August 14, 2023 with Chairman Ron Bride and Members Dave Henderson and Alan Yahnke present.

Dave Henderson made motion, seconded by Alan Yahnke and carried unanimously, to approve the agenda.

A County resident spoke to the Board regarding the dust control in front of his home being bladed by mistake. The board will speak to the Engineer to get any damages resolved.

Dave Henderson made motion, seconded by Alan Yahnke and carried unanimously, to approve and sign the Minutes of Monday, August 7, 2023.

The Board met with custodian Randy Norman, who mentioned general courthouse and grounds maintenance issues.

The Board met with Engineer Ryan Schock, who reported on blading, mowing, hauling rock, and the replacement of crossroad pipes on Scarlet and Nickel Avenues. When pipes are complete, rubber-tired hoe will then move to Wheat Avenue for ditching from south of Troy to Highway 2.

Bids were opened for the concrete work to be done on the shoulders of Timber Ave. in Pulaski from Huggins Concrete for \$48,000 and Wettstein Concrete for \$53,350.

Dave Henderson made motion, seconded by Alan Yahnke and carried unanimously to approve the bid from Huggins Concrete.

Alan Yahnke made motion, seconded by Dave Henderson and carried unanimously, to approve funding of the concrete shoulder project in Pulaski with part of the distribution received by the County, from the American Rescue Plan Act.

Alan Yahnke made motion, seconded by Dave Henderson and carried unanimously, to approve the GASB 75 Interim Actuarial Valuation, as prepared by the Howard E. Nyhart Company, Inc.

All Board members reported on committee meetings attended.
