The Davis County Board of Supervisors met in regular session on Monday, February 13, 2023, with Chairman Ron Bride and Members Alan Yahnke and Dave Henderson present.

Alan Yahnke made motion, seconded by Dave Henderson and carried unanimously, to approve the agenda.

Dave Henderson made motion, seconded by Alan Yahnke and carried unanimously, to approve and sign the Minutes of Monday, February 6, 2023.

The Board met with custodian Randy Norman, who noted that Huggins Electric will be disconnecting the electricity to the courtyard gazebo to allow for its demolition.

The Board met with Engineer Ryan Schock, who reported on work being done by the County crews. Their projects include blading, hauling rock and cutting brush. The Engineer is looking at options to repair road damage on Ice Avenue, south of Drakesville, which has been severely damaged due to heavy traffic from aggressive horseshoes.

The Board met with Don Walton regarding snow removal procedures for the portion of the Davis County Recreational Trail that is routed through the County McGowen Farm. Discussion was held about the possibility of removing snow from the historical bridge on the trail with a tractor, but concerned that crossing it with a tractor could be harmful to the bridge. The County will be completing the snow removal as much as possible from both ends of the bridge for now, until the weight limit of the bridge can be determined.

Alan Yahnke made motion, seconded by Dave Henderson and carried unanimously, to approve the tentative agreement reached between the County and the PPME Local 2003 Union (Secondary Roads) employees, for the contract year of 7/1/2023 through 6/30/2024.

The Board discussed the Mutchler Community Center's 28E Agreement and the City of Bloomfield's decision to provide financial support in the amount of \$40,000 for the next fiscal year, towards the Director's salary. The supervisors also plan to contribute \$40,000 from the County.

All Board members reported on committee meetings attended.
