The Davis County Board of Supervisors met in regular session on Tuesday, February 21, 2023, with Chairman Ron Bride and Members Alan Yahnke and Dave Henderson present.

Alan Yahnke made motion, seconded by Dave Henderson and carried unanimously, to approve the agenda.

Dave Henderson made motion, seconded by Alan Yahnke and carried unanimously, to approve and sign the Minutes of Monday, February 13, 2023.

The Board met with County Recorder Megan Clyman, regarding a work change request as a part of the digital archive imaging work, in the amount of \$301.00, due to the discovery of 6 additional books. Dave Henderson made motion, seconded by Alan Yahnke and carried unanimously, to approve the change request.

The Board met with custodian Randy Norman, who discussed regular courthouse maintenance.

The Board met with Engineer Ryan Schock, who reviewed the schedule carried out by the work crews of last weekend, due to the recent snow event. He also reported on the repair progress of the rubber tired hoe.

Discussion was held with the County Engineer regarding his employment contract. Dave Henderson made motion, seconded by Alan Yahnke and carried unanimously, to approve a 5% increase in the Engineer salary, for the fiscal year of 2024, beginning July 1, 2023, bringing his salary to \$92,088.91.
