The Davis County Board of Supervisors met in regular session on Monday, February 6, 2023, with Chairman Ron Bride and Members Alan Yahnke and Dave Henderson present.

Dave Henderson made motion, seconded by Alan Yahnke and carried unanimously, to approve the agenda.

Dave Henderson made motion, seconded by Alan Yahnke and carried unanimously, to approve and sign the Minutes of Monday, January 30, 2023.

The Board met with custodian Randy Norman, who reported on regular courthouse maintenance.

The Board met with Engineer Ryan Schock, who reported on projects being done by the County crews. He noted that he has set an appointment on June 7<sup>th</sup> to have the fuel tanks cleaned, allowing that school would no longer be in session at that time.

The Board met with Chloe Tenity, representing the office of Congressman Zach Nunn, for a brief introduction and information for contacting the Congressman and his staff.

Alan Yahnke made motion, seconded by Dave Henderson and carried unanimously, to approve a resolution to provide financial support to AHEAD Regional Housing Trust Fund for fiscal year 2023-24, in the amount of \$1,822.00.
