The Davis County Board of Supervisors met in regular session on Monday, January 26, 2026 with Chairman Ron Bride and Members David Henderson and Alan Yahnke present.

Alan Yahnke made motion, seconded by David Henderson and carried unanimously, to approve the agenda.

David Henderson made motion, seconded by Alan Yahnke and carried unanimously, to approve and sign the Minutes of Monday, January 19, 2026.

The Board met with Engineer Ryan Schock, who reported on blading, rock hauling and brush cutting activities of the County crews. He further stated that work on the “Rex Stewart Bridge” is waiting for a warmer week and that clearing, grubbing and bridge removal are happening at the “Richard Harris Bridge” site.

At 9:30 a.m., Jamie Papian and Logan Drake of Alliance Environmental Services joined the meeting by telephone conference to speak on results of an air quality test performed by their company at the Courthouse on December 29, 2026 and to address questions and concerns from the Board and other employees. They stated that considering the age of the Courthouse building, the air sampling and moisture levels were within normal range, there is no current health risk and the building is safe for employees and citizens to occupy. They further stated that the ceiling tiles previously stained by water could be the culprit contributing to the 13 spores/m3 of Chaetomium (a water damage indicating spore) in the Clerk of Court and Assessor Offices. Their recommendations were to replace the ceiling tiles as soon as new tiles are available, as they are currently on back order, after which their company could complete a post-remediation air quality test.

David Henderson made motion, seconded by Alan Yahnke and carried unanimously, to approve publication of the Davis County Annual Employee Wage Report from calendar year 2025, as follows:
