The Davis County Board of Supervisors met in a reorganizational session on Tuesday, January 3, 2023, with members Alan Yahnke, Ron Bride, and Dave Henderson present.

County Auditor, Linda Humphrey, called the meeting to order.

Alan Yahnke made motion, seconded by Dave Henderson, and carried unanimously, to appoint Ron Bride as the chairman of the Board of Supervisors for the calendar year of 2023. Ron Bride made motion to appoint Dave Henderson as vice chairman of the Board, for 2023, seconded by Alan Yahnke and carried unanimously.

Alan Yahnke made motion, seconded by Dave Henderson and carried unanimously, to approve the agenda.

There were no comments offered by the public.

Ron Bride made motion, seconded by Alan Yahnke and carried unanimously, to approve the minutes of December 27, 2022.

The Board met with custodian Randy Norman, and discussed regular courthouse maintenance.

The Board met with Engineer Ryan Schock, who reported that County crews had been placing road patch material on both Otter Trail and Timber Avenue, south of Pulaski. They have also been hauling rock and cutting brush.

Alan Yahnke made motion, seconded by Dave Henderson and carried unanimously, to reject a bid for bridge project BROS-SWAP-Co26(117) – SE-26 (a.k.a. Prevo Bridge), due to a date conflict with another project. Another letting date will be planned after July 1, 2023.

Alan Yahnke made motion, seconded by Dave Henderson and carried unanimously, to approve and sign the annual Title VI Assurance updates.

Alan Yahnke made motion, seconded by Dave Henderson and carried unanimously, to re-appoint Rick Lynch to a three-year term on the Davis County Board of Health.

Dave Henderson made motion, seconded by Alan Yahnke and carried unanimously, to appoint Jeff Cook to the Pioneer Cemetery Board.
