The Davis County Board of Supervisors met in regular session on Monday, July 13, 2026 with Chairman Ron Bride and Members David Henderson and Alan Yahnke present.

Alan made motion, seconded by David and carried unanimously, to approve the agenda.

David made motion, seconded by Alan and carried unanimously, to approve and sign the Minutes of Monday, July 6, 2026.

The Board met with County Assessor Jason Wagler, who presented the 2026 Homestead Credit and Exemption applications, the Disabled Veteran Homestead Credit applications and the Military exemption applications. David made motion, seconded by Alan and carried unanimously, to approve the following: redact 1 (one) Disabled Veteran Homestead application, 102 new Homestead Credit Applications, 60 new Homestead Exemption Applications, 8 Disabled Veteran Homestead Applications and 11 Military Exemption Applications per the recommendation of County Assessor, Jason Wagler. Assessor also noted 96 homestead cancellations and 21 military cancellations.
